

Q&A with Kiddie Campus' new director

As part of making MVCC an exceptional learning institution, the College created the Kiddie Campus Child Care Center over two decades. The Kiddie Campus provides a pre-school learning environment for children 3 to 5 years of age that promotes the development of the whole child.

On July 5, Jerylann (Jeri) George became the new Director of Child Care Services. The Head Teacher is Robin Saxe while Terry Ann Kipers-Szatko is the Assistant Coordinator. There are also five part-time teacher assistants.

Ms. Jeri sat down for a little Q&A.

Q: How is enrollment this fall?

A: "Currently we have four openings but we have a waiting list which will help fill those slots."

Q: What was instrumental to getting a full enrollment?

A: "I sent out letters introducing myself and informing parents of an Open House. I have found an Open House prior to the start of school is a good way for parents to get all the paperwork together and have time to fill it out. They get to look around and meet the teachers while the children have an opportunity to get excited about coming to school."

Q: How many children attend Kiddie Campus?

A: "The licensing is for 18 children, but due to the students' class schedule the children aren't here all day. That is where the flexibility comes into play. We may have 40 children signed up, but because of that flexibility we aren't exceeding the capacity of our license."

Q: What role does Kiddie Campus play in the success of MVCC students?

A: "Our priority is to make the student's experience at MVCC easier by respecting the fact that the parent is not only responsible for their studies, but also caring for a child and possibility working as well. It helps to ease their burden

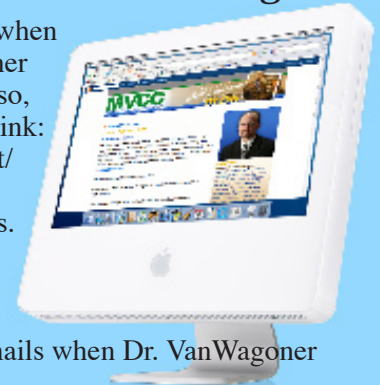

to know that their child is here and safe while they are fulfilling their academic obligations.”

Q: What are the security measures at Kiddie Campus?

A: “Every visitor must sign in and there are security key pads on all the rooms. The doors are kept locked unless you know the code. That is an awesome security feature. Teachers are constantly doing head counts which is very important because we have children coming and going throughout the day.”

Q: What is a philosophy of your’s when working with children?

A: “Children need to be around positive role models. They have a lot of energy and so you should have a lot of energy in order to create that positive atmosphere. This is their home away from home. We are a team working to help each other and the children to develop that comfortable atmosphere.”

Q: Having run a private daycare center for many years, what experience do you bring?

A: “Being the proprietor of a nursery - pre-school has prepared me in a huge way. From budgeting to maintenance, ordering supplies to overseeing the curriculum and staff, I know what needs to be accomplished.”

Q: What presentations would you like to arrange for the children?

A: “We’d like to take in the resources here at MVCC and use them to the benefit of Kiddie Campus. One of my thoughts is that we may be able to take a field trip to the college’s aviation department in Rome for a tour of the airplane. Another thought was the dental hygiene program where they could come and talk to the children about the importance of caring for their teeth.”

Q: What do you foresee in the future for the Kiddie Campus?

A: “We will begin the reaccreditation process within the upcoming year through NAEYC (National Association for the Education of Young Children).

Achieving this will take some time and preparation, but is a huge accomplishment for any child care center.”

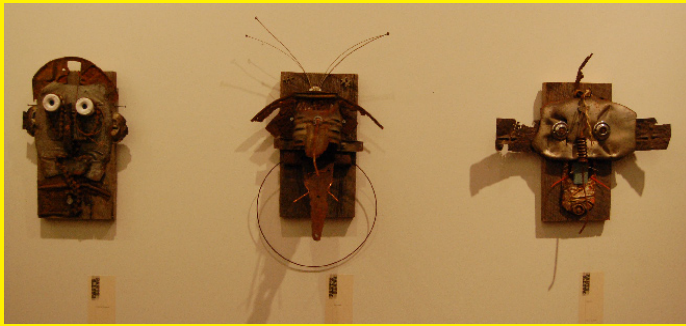
