

TRANSFER ARTICULATION AGREEMENT
between
MADDEN SCHOOL of BUSINESS at LE MOYNE COLLEGE
and
MOHAWK VALLEY COMMUNITY COLLEGE

This agreement establishes a formal articulation program between Mohawk Valley Community College and the Madden School of Business at Le Moyne College. This agreement provides Mohawk Valley Community College students with a plan of study that will maximize the transfer of credits toward specific baccalaureate degrees in the Madden School of Business.

OBJECTIVES

- To attract qualified students to Mohawk Valley Community College and to Le Moyne College.
- To recognize the combined programs as an alternate route to a quality undergraduate education.
- To facilitate the transfer process for students from Mohawk Valley Community College to Le Moyne College.
- To provide guidelines for enhanced student advisement and planning at Mohawk Valley Community College and Le Moyne College.
- To promote an efficient transition to qualified transfer students from Mohawk Valley Community College into identified majors at Le Moyne College.

ADMISSION REQUIREMENTS

While admission to Le Moyne College is competitive, students satisfying the following requirements will generally be accepted for admission:

1. Completion of the appropriate Associate Degree program at Mohawk Valley Community College as outlined in this agreement.
2. Completion of the course work at Mohawk Valley Community College with a cumulative grade point average (GPA) of 2.6 or higher. Students who do not meet these guidelines may speak with a transfer counselor at Le Moyne College about admission.
3. Proficiency in English, mathematics and the intended area of study must be demonstrated in the academic record. In mathematics, all students must have successfully completed at least three years of college-preparatory mathematics in high school (New York State Regents Course III) or intermediate algebra at the college level.

4. Candidates for transfer admission must file an application for admission during the semester prior to transfer. A completed application package includes:
 - Completed transfer application
 - Personal statement
 - Official high school transcript including SAT or ACT scores (and/or GED score report if applicable) if completing fewer than 24 college credits
 - Official college transcript(s)

TERMS OF THE AGREEMENT

- Mohawk Valley Community College agrees to adhere to the admission standards and other guidelines as set forth in the Le Moyne College Catalog.
- Le Moyne College agrees to accept for admission those graduates of Mohawk Valley Community College who make appropriate application and who meet Le Moyne College's criteria for admission as stated in this agreement.
- According to Le Moyne College policy, transfer credit will be granted for all identified courses completed at Mohawk Valley Community College with a grade of "C" or better.
- Le Moyne College agrees to accept as juniors those students who have completed 18 courses (or 54 credit hours) outlined in the attached articulation agreement for their intended major with a grade of "C" or better.
- The maximum number of transferable credits into any Le Moyne College curriculum from Mohawk Valley Community College is 60 credits.
- Le Moyne College will provide financial aid for Mohawk Valley Community College students who transfer as a part of this agreement to the extent of normal institutional guidelines and contingent upon documented need. Contact should be made with the Le Moyne College Office of Financial Aid (315-445-4400) regarding filing procedures.
- Mohawk Valley Community College students who are interested in entering baccalaureate programs not covered by this agreement will follow established transfer admission procedures. These students are encouraged to seek advisement from the Director of Transfer Admission in the Le Moyne College Office of Admission (315-445-4300).

REVISION OF THE AGREEMENT

The appropriate administrative offices at each institution will discuss substantive changes in courses or programs affecting this agreement at either Le Moyne College or Mohawk Valley Community College. The agreement will be reviewed two years from the date of signing. It may be modified upon mutual agreement and may be terminated by either party upon written notification.
