Underlying Principles of Quality Standards Review

Quality Standards Review Criteria

1. Course Overview and Introduction

General Review Standard: The overall design of the course, including online and face-to-face (Hybrid courses) components such as navigational information and course, instructor, and student information, is provided to the student at the beginning of the course. (Note: Navigational and other technical information should be provided in the course shell.)

1.1. Includes a brief tutorial related to Blackboard menus and platform functionality.

Navigational instructions make the organization of the course easy to understand.

1.2. Includes a course description from the catalog, additional basic course information (including course structure), instructor expectations of student performance, and necessary prerequisites.

1.3. Netiquette expectations with regard to discussions, email, and other forms of communication are stated clearly.

1.4. A self-introduction by the instructor to include an educational, and/or pedagogical philosophy.

Personal information may or may not be included in the introduction

2. Course Learning Outcomes and Competencies

General Review Standard: Course learning outcomes are clearly defined and explained in relation to the degree program competencies.

2.1. The course learning outcomes are aligned with degree program competencies and are assessable.

2.2. Course activities, including assignments, address learning processes that are measurable and are consistent with the course-level outcomes.

2.3. The course learning outcomes are stated clearly and are written from the students' perspective.

General Standard II - Comments and Recommendations

3. Assessment and Measurement

General Review Standard: Assessment strategies effectively measure student learning in support of, and progress toward, stated learning outcomes.

3.1. The types of assessment activities selected measure the stated learning outcomes and are consistent with course assignments.

General Standard III - Comments and Recommendations

4. Resources and Materials

General Review Standard: Instructional materials, or guidance related to obtaining these materials, are sufficiently comprehensive to achieve learning outcomes. Materials are prepared by qualified persons who are competent in their fields.

4.1. The instructional materials, when appropriate, support the stated learning objectives. In instances where instructional materials are identified and selected by students, guidance is provided related to appropriate selection process.

4.2. The instructional materials have sufficient breadth, depth, and currency for the student to learn the subject. In instances where instructional materials are identified and selected by students, guidance is provided related to appropriate selection process.

General Standard IV - Comments and Recommendations

5. Learner Engagement

General Review Standard: The effective course design creates an environment where student motivation can be supported in multiple ways by the instructor, the course material, instructional design, learning activities, visual layout/design of the material, use of technology and other factors that engage students in the learning process.

5.1. The learning activities, either individually or collectively, promote achievement of stated learning objective.

5.2. Learning activities foster instructor-student, content-student, and if appropriate to this course, student-student and student-research interaction.

General Standard V - Comments and Recommendations

6. Course Technology

General Review Standard: To enhance student learning, course technology enriches instruction, fosters student interactivity, and increases access to instructional materials and resources.

6.1. The tools and media support the learning outcomes, and are appropriately chosen to deliver the content of the course.

General Standard VI - Comments and Recommendations

7. Learner Support

General Review Standard: Courses are effectively supported for students through fully accessible modes of deliver; resources, and student support.

7.1. The course instructions articulate or link to a clear description of the technical support offered.

General Review Standard VII - Comments and Recommendations

8. Accessibility

General Review Standard: The electronic and online course components are accessible to all students.

General Review Standard: The electronic and online course components are accessible to all students.

8.1. The course acknowledges compliance in accordance with Federal regulation 508 and American Disabilities Act (ADA) requirements.

8.2. Course pages and course materials provide equivalent alternatives to content that is relevant to the needs of all students, including those with learning, hard-of-hearing, visual or physical disabilities,

Examples: Course pages have visual descriptions that are self-describing and meaningful; captioning, etc.

8.3. The course shows equal access to alternatives for students using adaptive/assistive technologies to help people who have disabilities gain access to information that might otherwise be inaccessible.

Example: separate websites/ links not under the control of MVCC that might not be accessible
